### **Demerit Points:**

If you currently have any demerit points recorded against your NSW driver's licence you must select **Yes**. If you are unsure of your demerit point status, visit [www.service.nsw.gov.au/transaction/check-your-demerit-points](http://www.service.nsw.gov.au/transaction/check-your-demerit-points)

### **Youngest driver's date of birth:**

The date of birth of the youngest person who will drive the vehicle **at any time**. The driver does not have to be a 'regular' driver. Learner drivers do not have to be included unless the vehicle is to be registered in their name.

### **When they obtained their driver's licence:**

Please enter the age that the youngest driver obtained their provisional driver's licence, not their learner's licence.

### **At Fault accidents / claims:**

At Fault claims include any claims arising from the use of or operation of your vehicle for which you or any driver of your vehicle were deemed to be partly or fully responsible for. Claims for such things as hail damage or damage caused by a collision with an animal should not be included.
